They are examining the use of virtual learning and collaborative online international learning across the globe. In particular, the team is interested in researching comprehensive internationalisation practices, embedded in the broader context of curriculum transformation. This requires understanding the contribution of virtual exchange and online collaboration within internationalisation at home practices, and the overlap of wider internationalisation of the curriculum strategies, at the interface of decolonisation of the curriculum.
